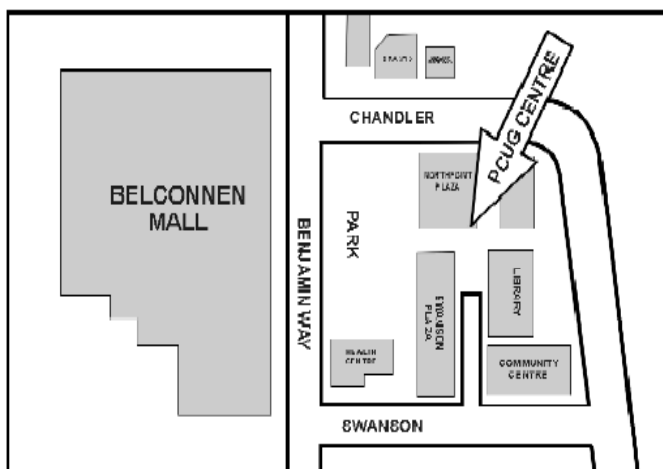

Report on Committee Meeting 12 July 2004

The Committee briefly reviewed progress on updating the PCUG web site and the automated payments system. It agreed that the proposal for an Internet Only Membership should be circulated to members for comment and expressions of interest (see elsewhere in this newsletter).

The next Members Information Session will be held in the PCUG Centre starting at 2pm on Saturday 11 September. Work on updating the Help Directory is continuing and hopefully the updated Directory will be published in the August Newsletter.

The Committee met with John Plumidis who has offered to start a Youth SIG. The Committee welcomed this initiative and assured John of its support.

The Treasurer reported that the financial result for the year ending 30 June was much as expected. The cash surplus for the year was \$38,000. He warned that the continuing fall in membership will make it difficult to maintain a positive financial position in the coming years.

The Committee reviewed planning for the Annual General Meeting, to be held on Monday 27 September at 1930. Calls for nominations to the Committee in the following year will be issued soon. A copy of the draft minutes of the 2003 AGM will be placed in the web site for perusal by members, and the audited financial report will also be placed there if it is available in time.

Paul Free reported on the results of the consultation with members which ended recently. Over 25% of the membership had responded to the survey - a most satisfactory result. A wide range of opinions and comments was submitted by members. A full report on the results of the consultation and the Committee's response to them will be published before the Annual General Meeting.

A report on the ongoing discussions with the Belconnen Community Service was considered. A submission had been made to the ACT Government seeking funding for a jointly operated service in the Belconnen area aimed at assisting people who are currently disadvantaged in the use of computers and the internet. If the joint service is established PCUG will be committed to providing volunteer support and the availability of the Centre to the project.

The bulk of the time at the meeting was taken in discussing options for the future of the PCUG Centre. The current lease expires on 30 November. Options to move to a smaller set of rooms elsewhere were considered as well as the option of remaining at the present location but reducing the area we rent. The financial implications for the club were a major consideration as the cost of the Centre currently absorbs 70% of membership fees.

The Committee agreed to begin immediately discussions with the landlord to explore the cost of retaining the current Centre.

PCUG Internet Service

PCUG has recently made more improvements to the PCUG Internet Service

Transparent proxying on our internet service has now implemented. This means that you no longer **MUST** specify a proxy server in your browser configuration. The proxy server will continue to be used for all standard world wide web traffic. Existing configurations will continue to work and there is no need to change them.

If a proxy server is configured, that will be used. If none is specified, the TIP system will automatically forward all standard web traffic to our proxy server.

The TIP servers are now protected by a firewall. The servers are set up so that any connections initiated from them are OK, but inbound connections are only allowed to certain standard ports.

Currently the following ports inbound to all our machines (including members) are blocked:

TCP: 69 sunrpc ldap ldaps 135-139 445

UDP: tftp sunrpc snmp snmp-trap 2049 ldap ldaps 135-139 445

And outbound TCP: 135-139 445

The 135-139 range and 445 are to prevent the spread of the recent MS viruses that seem to be still with us.

Effective the beginning of February we have added six more modems for use by dial-up users, giving our dial-up users access to a total of ninety modems.

Problems Logging into the Internet Service?

If you ever find yourself failing to log in to TIP, **STOP** and don't waste any more money trying to dial in again. The two major reasons for failing to login are firstly, you have run out of TIP or PCUG membership, or secondly, your Username and or your Password have become corrupt. Paying more money fixes the first problem, re-typing your Username and Password into the Log In dialogue fixes the second problem 99% of the time. If neither of those fixes works for you then telephone the PCUG Centre and ask for help (unless you can access someone elses email, in which case send an email to <help@tip.net.au>.

Proposed New Membership Category

The PCUG Committee is considering a proposal for a new category of membership in PCUG, and invites members to comment on the proposal. The new category would be "Internet Only Membership".

Internet Only Members would pay a single annual PCUG membership fee, which would pay for their internet service and club membership. The fee would be slightly higher than the current price for the various Internet services alone, as the current pricing is based on best price for PCUG club members, but less than the current price for Internet Service plus Full Membership. Internet Only Membership Fees would only be offered as an annual subscription and not 3 or 6-month plans. The Membership Fee for Internet Only Members would entitle them to access the PCUG Internet Service, but would not entitle them to any other services available to Full Members.

Internet Only Members would receive Internet help (connection or technical) via Email or newgroups only. Telephone assistance would not be offered. The Internet Only Members would not have access to the Belconnen Centre other than to pay their renewal fees, nor to the members price for training courses. They would not have access to any of the PCUG supported SIGS. The Internet Only Member would not have access to the HIT teams or would be able to be a member in a HIT team for support.

Internet Only Members would need to remain financial at all times, as no grace periods for renewal will be offered. Mailboxes and home pages would be deleted once the member becomes non financial. A reconnection fee will then be charged if the Internet Only Member wants to reconnect after disconnection.

CHEAPER INTERNET SERVICE

PCUG Internet Service charges for dial-up Full Service users are now -

- Pay in Advance for 12 Months or 360 hours on line (which ever comes first) - \$119.00 (\$9.92 per month)
- Pay in Advance for 6 Months (or 180 hours on line (which ever comes first) - \$69.00 (\$11.50 per month)
- Pay in Advance for 3 Months (or 90 hours on line (which ever comes first) - \$39.00 (\$13.00 per month).

Broadband service via TransACT charges are as follows -

- Pay in Advance for 12 months or 7,200 Mb downloaded (which ever comes first) - \$280.00 (\$23.33 per month)
- Pay in Advance for 6 Months or 3,600 Mb downloaded (which ever comes first) - \$145.00 (\$24.17 per month)
- Pay in Advance for 3 Months (or 1,800 Mb downloaded (which ever comes first) - \$75.00 (\$25.00 per month)

Members are encouraged to take advantage of these very competitive prices with the assurance that they will never pay excess charges and when internet prices come down further they will again benefit.

Windows Security Update CD Free from Microsoft

Microsoft is offering a Windows Security Update CD-ROM that includes most of the critical updates for Windows 98 (first and second editions), Windows Millennium Edition (ME), Windows 2000, and Windows XP. The CD includes all of the critical updates released up to October 15, 2003. There is no charge for the CD - not even a shipping charge. You can order it by going to <<http://www.microsoft.com/asia/default.asp>>.

I recommend you order the CD if you are using any of the ` operating systems that it covers, even if you have regularly installed the updates. If you already have the updates, it will save you time and trouble if you ever have to reinstall Windows. If you have not kept pace with the updates, by all means get the CD and install the appropriate ones for your operating system.

Please note that the CD does not include any updates issued after October 15 of last year. There have been a number of them. Therefore, if you have been keeping up with the Windows critical updates, please continue to do so. If you have not installed any of the updates, I suggest that you wait until you get the CD, install the appropriate updates, then go to the Windows Update Web page and get the ones that you don't already have.

The Constitution of the PC Users Group (ACT) Incorporated (As Amended to September 2003) states (among other things)

17. Election of Committee members

(1) Nomination of candidates for election as office-bearers of the Association or as ordinary Committee members can only be made by current and financial members of the Association, and shall be made by delivering a completed Committee Nomination Form to the Association no later than six days before the date fixed for the annual general meeting at which the election is to take place ("the election date").

(2) If insufficient nominations are received to fill all vacancies on the Committee, the candidates nominated shall be deemed to be elected.

(3) A vacant position remaining on the Committee shall be deemed to be a vacancy for the purpose of Rule 16(4).

I once promised myself not to become addicted to simple, easy-to-play games. Instead of losing all those hours to Minesweeper and Solitaire, I could have been... oh wait, it's school holidays.

Thus I find myself reviewing 3D Magic Mahjongg Holidays. The game consists of a board full of colourful tiles. Match two identical 'free' tiles to remove them from the board, eliminate all tiles to complete the game. Simple?

Wait, the game is in 3D. Tiles are stacked on top of and around each other, hiding tiles from view. Worse, the designs on each tile can be deceptively similar. This increases the difficulty of the game. Fortunately, the intuitive controls, interactive help pop-ups, and online help each make learning the game relatively painless. Viewing the complete board is made easy via the rotate and zoom controls,

The tile designs, backgrounds, and even the MIDI soundtrack can be customised according to 'holiday' themes - 4th of July, Christmas, Easter, Valentine, and Halloween - as well as some less festive designs. I wasn't impressed with the default theme, filled with American stars and stripes. In my preferred Halloween theme (set to the 'Nightmare' soundtrack), translucent ghosts cross the screen, disappearing in a puff of smoke with a click of the mouse. I appreciated the attention paid in 3DMMH to such details.

What makes this game addictive is the countdown timer. This means that clearing the board becomes a race against the clock in an effort to set a new high score. Making use of the 'hint,' 'undo' or 'shuffle' functions (the latter rearranging the tiles - handy when no available moves are left) incurs a time penalty, rewarding the bright sparks who can think two moves ahead.

The developer of 3DMMH, Suricate Software (www.suricate-software.com <<http://www.suricate-software.com>>), specialises in family-friendly games. Suricate has kindly offered 30% off the purchase price of 3DMMH to PCUG members who order via their website (8.1Mb download). Be sure your PC has DirectX 8.1 pre-installed, and is at least a PII 300Mhz with a 3D accelerator card. The test machines were a P166 (the game failed to load) and a P4 (Seamless!).

Also available from the website are similar Mahjongg and other family-friendly games, including free demos. I look forward to an Australian Holiday Mahjongg - complete with themes for ANZAC Day, the Melbourne Cup, and the trip to the beach.

CD's Are Not Immortal!

Despite claims by manufacturers, CDs – and DVDs, which are after all made in exactly the same way – have now been shown to be anythingbut immortal. In fact, some CDs, recorded in the 80's, have shown distinct signs of what has been called CD rot.

I feel that it was somehow ironic that I came across this article (<http://www.eweek.com/article2/0,1759,1585525,00.asp>) in the evening of the day when I'd just run a session at Chez Georges on transferring LP's to CDs. Apparently the discovery was made by somebody who has an extensive (something like 2000+) CD collection, that they had packed away during a move. On unpacking these CDs, the poor sod discovered that some CDs, mostly the older ones, wouldn't play, or if they did, sounded terrible, with cracks and skips. And here he had thought that the bane of Vinyl had been defeated!

Apparently his collection was suffering from what the experts now term CD rot. If you look at a CD, or a DVD for that matter, you will notice that it consists basically of an aluminium disk, with a thick (you'll have to take my word for that!) layer on one side and a thin layer on the other. The thick layer is where you record stuff when you burn a CD, the thin layer simply covers the label, if any, on the top side of the CD.

And that is where the problem lies – in the thin top layer. Mechanical abuse – which apparently can be something as simple as using a biro to label your CD to the flexing that can occur when you get one of those sticky Jewel cases that virtually force you to bend the CD to get it out – is the primary cause. Such mechanical abuse can break the thin top layer of plastic, and let the air in. And, believe it or not, aluminium "rusts" just as much as iron. For the benefit of those who slept through Chem101 at school, rust is simply the result of an interaction of oxygen and a metal. Most of us are well and truly familiar with that phenomenon when it comes to iron products. When you clean off the rust, you're left with tiny pits. If the sheet of metal is thin, these pits will go straight through.

But, as your CD depends on the shiny aluminium disc to reflect the laser beam back into the player, when you get pits (or, more precisely, holes) in that disc, the laser beam will go straight through. If you're playing music, I presume this will result in a spot of silence – and if there are not too many of them, you'll probably won't even notice these "silences". But, with data, it's a different story. As you know, digital data is really simply a collection of zeros and ones. On a CD these are represented as holes in the plastic – which means the laser beam gets reflected one way – or flats, meaning the laser beam gets reflected another way. In actual fact, only the laser beams reflected from one (or the other – my references aren't explicit on this) are counted, the others are ignored. But, if the laser beam should have been reflected, but wasn't, because there is a hole in the bucket (err... aluminium disc), you'll get something else that what was intended – an error.

Some of the experts have said, we were all only too well aware that our vinyl discs were "vulnerable" – to dust, scratches, finger prints and mould in the tropics! – Ivan), and we treated them with care. But CDs, we were told, were virtually indestructible. It seems that CDs are vulnerable to much the same things as our vinyl records, except that it is the non-playing top side that is actually the problem.

What do the "experts" recommend? Well, for a start, they suggest that you have a good look at all those "old" CDs you have lying around, and check them for any sign of discolouration. "Rust" on aluminium looks like a white powder. Any that are affected, the "experts" recommend you either replace or, if that is still feasible, re-record. They are, however, remarkably silent about how to cope with data CDs – or possibly there were none that far back?

Second, they recommend that you should handle CDs with the same care that you'd handle vinyl records – fine, if you're old enough to remember what vinyl records looked like! Apparently pasting labels onto CDs is a distinct No-No – makes me wonder what the printing process (by which means you get those pretty labelled application CDs!) does to that "fragile" top layer. Another No-No is using anything but soft pens – water or alcohol based – to write on CDs, because pressing hard down to write on a CD can break the top layer.

And, last but not least, finger prints. On the underside of the CD they can cause trouble by deflecting the laser beam, on top they cause trouble because they contain acids. And, as the experts point out, all it takes is one minute break. For maximum longevity, CDs should, just like your vinyl records, be stored vertically. Both plastics and metals expand and contract with heat – another way of getting a crack. Store your CDs therefore in a cool dry place. Handle them by the edges, and try not to bend them.

What really got me though was that apparently there is no way of verifying manufacturer's claims of CDs longevity, mainly because they can, and frequently do, change production methods and materials, without telling anybody, least of all the final user. As one expert commented, if you went to a store and bought the same brand of CD now as you had bought six months ago, there is no guarantee that they are the same – so much for sticking with a "reputable" brand.

What I find amusing out of all this is that here goes another myth of the 'digital' age. Remember how we were going to be able to ditch paper, and keep all of our records electronically? I have quite a few books in this house which are well over a hundred years old, we own several "vinyl" records that are sixty or more years old, which are still as good as they were when the family first got them (well, most of them – some got a bit worn entertaining the kids!).

So next time you consider transferring your LPs to CDs, do so for the convenience of playing them – in the car or your portable CD player. Just don't kid yourself that the CDs will last.

POPFile - More than just a spam filter.

Whilst many folks are very happy with Mailwasher as their spam filter, I've been experimenting with another spam filtering method, written by anti-spam and open-source enthusiast John Graham-Cumming, called POPFile (source:

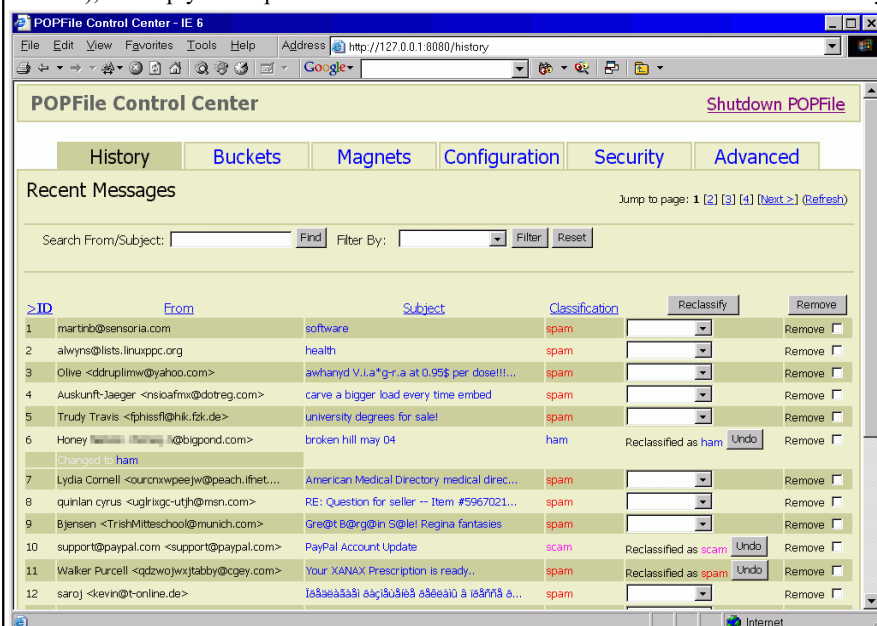
<http://popfile.sourceforge.net/>). Unlike Mailwasher, which you use as a separate mail client for previewing e-mails and deleting suspected spam and viruses, POPFile fits itself into your internet mail protocol. It requires a pretty straightforward change to your mail client (alteration of mail server and account details) and needs the POPFile server to be running when you download mail. It works as a *proxy*, much like many e-mail-virus-checkers. It then tags all downloaded e-mail based on the content, either with an alteration to the subject line or through an additional header, and your e-mail client can deal with the e-mails as you wish.

POPFile implements what is called a *naïve Bayesian* algorithm, which basically uses raw statistics on word occurrences and frequencies within each e-mail body and its headers. As a quick frinstance, the word Viagra appears in many e-mails that most of us would consider spam. However, if you are a doctor specialising in spinal cord injury in males, it might be a legitimate word in some of your correspondence. In most spam, the word Viagra (or, these days, V1agra, Vi@gra, Via8ra, etc) might also contain the word “click” or “buy” whereas the SCI doctor might find the word spinal or dysfunction occurs in e-mails that also contain the word Viagra. As POPFile learns these distinctions, you have to teach it when it makes a mistake. This way, it builds up a “corpus” (“*body*”) of statistical occurrences of each word, with a probability of whether it will occur in spam or not. After about 100 e-mails, it is about 90% accurate. The nice thing about POPFile (at least in theory) is that as spammers find new methods for defeating keyword identifiers, POPFile adapts to these, often “guessing” correctly the first time. By 500 e-mails, expect about 95% accuracy. By 1000 e-mails, expect about 97% or more accuracy. For me, the accuracy is 95% after 1000 e-mails, and 95.9% after 1500 e-mails.

POPFile accuracy stats (source: http://www.usethesource.com/popfile_stats.html) were gathered from 367000 returns over the last 12 months.

So how do you train POPFile? It keeps a separate history of the last two (configurable) days' worth of messages. If you find a new message in your e-mail client that has been misclassified or left unclassified by POPFile, you can either double-click on the reference header that POPFile put in there (at least, Agent lets you do this very very easily. Outlook and OE are a bit more fiddly for access to headers), or simply start up POPFile's user interface and select the e-mail from the history list. Either way, it is then just a matter of



using a drop-down box to reclassify the message.

I should point out that POPFile can do more than simply classify the dichotomy of spam and not-spam (or ham, as I prefer to call it). For instance, I have classes (called “buckets” by POPFile) for spam, ham, virus-or-worm, scams (eg Nigerian ex-trade-ministers, or bank impersonators), and other noise (eg bounce messages from well-meaning postmasters who haven't yet twigged that most return addresses of spam and viruses are forged, or bounce messages from MailWasher users). Whilst this isn't necessary for differentiating wanted from unwanted e-mail, it is of mild academic interest. For instance, of the 220 messages I had received in 16 days before TIP's spam-filtering was turned off, 111 (yes, half of them) have been spam, 59 (about a quarter) virus-or-worm, 6 scams, 1 bounce message, and 43 real messages. The twenty mistakes it

made (it is still learning) were 15 false positives on ham and 5 false positives on spam. Nine more messages it declined to adjudicate on. In the six days since the above stats were collected, spam filtering at TIP was turned off, and my results are now, of 303 new messages, 215 were spam (nearly ¾!), 38 viruses (about 1/8 netsky has now died down), 13 scams, 7 bounces and 30 real messages (less than 10% , the price you pay for internet fame?!?). My long term averages are now 66% spam, 14% viruses, 14% ham. So, what does POPFile look like? The most common things in POPFile that I want to do is reclassify e-mails, or look at the stats. Here's a snapshot of the history screen, which shows your most recent messages.

As you can see, it is very easy to reclassify any message. (This capture contains many more reclassifications than what I normally do: less than one in ten, and falling). You can see how I had to teach POPFile about the PayPal scam (a false negative on scams POPFile thought it was spam), the announcement that my XANAX (what's XANAX?) is ready (a false negative on a new type of spam), and worst of all, my friend's HTML newsletter to over fifty friends. Strictly speaking, it had a lot to say it was spam (multiple recipients, HTML content, embedded photos, bigpond as a source), but in this case POPFile was wrong. This raises a very important point in dealing with spam. *Never bin spam before you have checked it.* I had to retrieve this message from the SPAM folder (very easy in almost any newsreader) before deleting the rest.

The buckets page shows both statistics on how POPFile categorises things, as well as category-specific settings (like whether POPFile should add "[spam]" to the subject line, or add an X-Text-Classification header, or a POPFile-Link (a handy URL to the message on the local POPFile server, eg `http://127.0.0.1:8080/jump_to_message?view=popfile144=1.msg` which of course only works whilst the message is in POPFile's recent history) . The bottom lines are the Messages Classified table, and the Accuracy Graph. These show what your breakdown of messages is, and how well POPFile is doing at automatically sorting it for you. So the above capture shows POPFile made a mistake with 38 classifications, and couldn't confidently classify 20 more. So I've only had to intervene for 58 out of 523 messages, and I'm expecting it to improve. (Since then, accuracy has climbed to 95.9%, and I now intervene in about one in 25 messages).

So what's under the bonnet?

POPFile is written mainly in Perl, implemented in the Windows distribution by a standalone Activeperl. The authors really liked Perl for its portability and its string handling. The database end is powered by MySQLLite. Both of these systems are installed with POPFile, under the GNU Licensing Model (more or less freeware). Most of the processing is done by a resident program (a "daemon") which you configure your e-mail client to ask for messages. The daemon will then ask your normal mailhost (eg the mail server at TIP, but it can be any host) for e-mail. It scans the e-mail as it comes in, performs its little statistical magic on the content and based on that decides which bucket the message belongs to. Then, based on what you have asked POPFile to do with that bucket, it will mark it accordingly and pass the e-mail onto your mail client. Then, if you have configured your mail client correctly, the message will be filed in an appropriate mail folder, or subjected to other sorting, based on other headers. In fact some users of POPFile use it for sorting their real mail as well.

Whilst installing and setting up POPFile is pretty straightforward, it can have its moments. It worked perfectly on my Win 98SE system first time. However it took some major tweaking on my XP system at work, and I abandoned it due to apparent conflicts with Vet antivirus' mail scanning (work already had SpamBully anyway). POPFile used to occasionally hang on my 98SE system, something easily fixed by closing and restarting POPFile, but I have not had any hangs since I removed their handy systray option. Like many open source software projects, it is hard to make one size that fits all operating systems.

Whilst not as hand-and-glove as SpamBully for Outlook Express and Outlook, and missing the sometimes aggressive blacklist facility of MailWasher and SpamBully, POPFile fills an important niche for bold folks who want a spam filter that they can get their teeth into.

We have had people wait 2 months or more B4 doing something about faulty goods and then wanted a refund. Most dealers won't refund (if they have a refund policy) after a certain period of time.
