

ISSC Report

PCUG TIP Announces Availability of Email Aliases for Paid Service Users

PCUG announced last month that, effective immediately, TIP users with Full and Broadband Access accounts (paid services) are entitled to apply for and use up to five email aliases in addition to their existing email address.

Email aliases are additional email addresses which will be seen by outsiders as a different email address, but all emails addressed to that address will in fact be directed to the TIP User's primary email address. However as the TO address in the email will remain as addressed, Users can use the filter function in the email client to direct each alias to a different folder. No additional mailbox quotas are associated with email aliases.

Email aliases may only be applied for by the person who has a Full Service Dial-up or Broadband account with TIP. Aliases are only to be used for the account holder and members of his/her immediate household for personal (non-commercial) use. The TIP Postmaster may reject any application for an email alias that is not in accordance with policy.

Application for, and use of, these email aliases must be in accordance with the "TIP Policy for email aliases", which is published on the TIP web server at:

RENEWING YOUR PCUG MEMBERSHIP TIP OR BROADBAND

Members are reminded that they must provide both their username (first part of e-mail address) and membership number when they renew membership for TIP or Broadband.

Note that your credit card details are safe when you use these sites.

Please check all details before you submit the payment including the card expiry date.

However if you must renew by mail or telephone, it is essential that you correctly identify yourself with both username and PCUG membership number.

Members who fail to provide correct information may find that their payments have not been credited to them or that their renewal is withheld until details can be checked.

Please ensure that all details regarding your membership is up-to-date. Each month we have approximately twenty magazines returned because the addressee no longer lives at the address on the label that has been produced from the database. With the cost of postage on the rise your assistance is sought in this matter.

SPAM

(not to be confused with PREM, MOR, or TANG)

I have been somewhat slow to complete this article because every time I thought that I had finished it some new and fascinating piece of information appeared. However, if you do not feel troubled about Spam you may wish to skip the main text and go directly to the final parts which list recent newspaper extracts and web pages.

Spam has attracted much interest lately and several members have asked questions but especially "what is PCUG doing about it?" A friend of mine in USA has abandoned his e-mail service because Spam wastes so much of his time. My daughter, also in USA, complains about the unwanted and objectionable messages which she receives through Hot-Mail. For me my only complaint is a friendly gentleman in Nigeria who occasionally asks me to send him my bank address and number so that he can send me some money surplus to his present requirement. Needless to say, I have not acknowledged his kind offer

The Internet, which offers so much to assist world wide communication, is being damaged by the growth of Spam. Some argue that this is simply like the junk mail which appears in our letter boxes and, as such, is an equally legitimate form of advertising. In fact it is far more intrusive because so many messages can be sent simultaneously. The odd junk letter in your mailbox is quickly dropped into the garbage bin but spam may arrive in bucket loads and much time is wasted in identifying the unwanted messages and deleting them. It has the capability to severely clog the communication systems of the world.

What can we do?

There are several steps that we as users can take to reduce the impact of Spam on us.

- Ø Firstly, when you receive spam never answer it even to ask to be deleted from the mailing list. That only tells the sender that it has found a valid address which can be passed to others.
- Ø Secondly, be extremely carefully to send your e-mail address only to secure sites on the web. Other sites may be subject to interception by hackers who can record your address.
- Ø Thirdly, install a firewall. There are many hackers who attempt to infiltrate other computers for their own purposes.
- Ø Fourthly, install your own filter system such as Mailwasher. This lets you create a black list whilst still letting your friends mail through. It will let you sight, without reading in full, any message of doubtful quality.
- Ø Lastly, Google is ,always, your friend and a simple question "anti spam" will yield a host of valuable advice. Some references from this source are given below.

What can PCUG do?

Other than educate members about spam, there is very little that the Group can do. However, TIP operates a vigorous anti-spam regime on external blacklist sites which are checked before e-mail is accepted. There are also several checks internal to TIP to reject known spam sources. Both these methods are constantly tuned by TIP admins.

What is happening elsewhere?

Many authorities around the world have become very concerned at the damage being caused by Spam and various cures are being tried. The Sydney Morning Herald of 21 April reported on a "Concerted effort to beat spam". This included

- Ø The Australian Internet Industries Association has started its own anti-spam campaign.
- Ø Tel-Net Media says its Anti-spam Sheriff provides organisations with server based filtering.
- Ø Hotmail/Ninesman offers four anti-spam filtering products to people with Hot-mail accounts.

However, all of these have some limitations and may isolate you from messages which you really wish to receive. As quickly as providers find cures for spam, the senders will be working to overcome them.

A more stringent approach is being adopted by some governments in the USA by imposing fines and other penalties on those responsible,. The difficulty will, of course, be to actually identify the offenders and to impose the penalty.
