### February Monthly Meeting

#### "What you Need to Know about Printers"

**Speakers - Gordon Urquhart and Des Pfeiffer.**

All Welcome.

Gordon and Des will tell us about the issues that one should consider when buying a printer, how printers work and the traps to be aware of. They will talk about the costs of operating and maintaining printers, cartridges and the options to get the best value from your printer. Des will tell us about recycled printer cartridges.

Following the talks by Gordon and Des there will be a general Questions and Answers period during which we will invite members to ask questions of both speakers.

Des Pfeiffer is the principle of Printer Cartridge Recharge in Canberra. Before acquiring the Printer Cartridge Recharge business 12 years ago, he worked as a typesetter at The Canberra Times for 3 years and then at the Government Printing Office for 18 years. He joined ACRA [Australasian Cartridge Remanufacturers Association] in its infancy, mainly to learn & set standards for laser cartridge remanufacture. There are now 208 members across Australia & New Zealand. The Association organises a yearly EXPO where worldwide suppliers attend to promote new products and discuss refilling techniques. He has also completed courses in basic printer repairs and maintenance, mainly with the HP III laser printers.

Gordon Urquhart has been a PCUG member for 10 years with a general interest in hardware. He assists members with hardware and software problems.

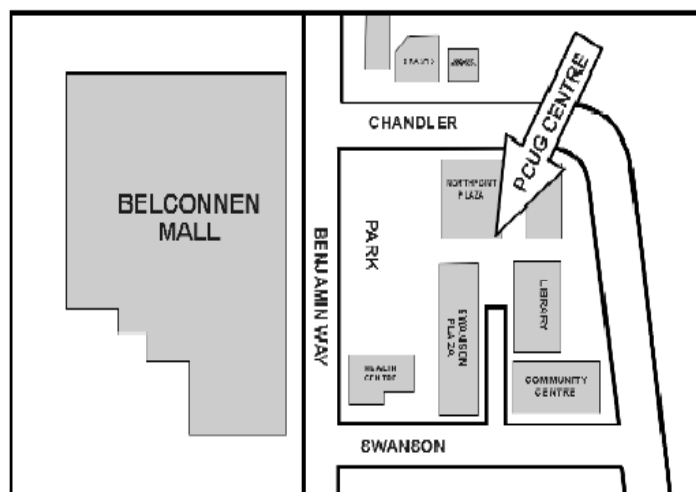

### President's Report

One interesting aspect about involvement in a voluntary organisation is the effect positive thinking, or its reverse, negative thinking, has on the future of the organisation. Some three or four years ago a committee member of considerable experience, and with heavy involvement in TIP, stated that we would close down within twelve months. Hello, we are still here.

Financially we are not as well off but our financial structure is very much sounder even with reduced member numbers. The financial situation is partially my fault (I hasten to add in a very small way). I was the only non admin member of our Internet Project Management Committee (IPMC) at a time when the Executive was also dominated by TIP admins. The decision was made (I think unanimously but I can't recall) to run down reserves from previous TIP income by undercharging for internet services. Since then there has been much criticism of PCUG's annual losses. Few have made the logical connection that this was mainly caused (there are other reasons also) by the losses from TIP as TIP had become part of the PCUG and its profit and losses were incorporated into the overall PCUG accounts. (No - don't join in that old chestnut that TIP has always run at a profit. There are issues about how to measure which expenses and income should be charged against the TIP component of PCUG but it is incontrovertible that that decision resulted in us running at a loss even if TIP's component of the shared costs were not charged back against TIP.)

Thinking positively - was that decision right? I believe it may have been but for the wrong reasons. The lowering of charges for internet services from other providers has lead to us losing members who have found some schemes better suited to their needs. If we had charged for internet services at the then true rate we would have lost more members. We were also inefficient in seeking out the cheapest provider of internet content and even when we started to do so we signed for two years in a market where charges for these services were reducing rapidly. Last year (thanks Michael Lightfoot) we went through a strongly competitive tender process and the reduced rates made us more viable. This year (against some internal resistance) we are doing so once again and, even before we have an outcome, our contract for the coming year will be less than last year's. But

we still have problems. A major one is trying to create new options for members in a volunteer organisation where we are reliant on those volunteers who do a magnificent job in those areas they are interested in but who don't recognise that TIP and PCUG's futures require that their efforts be directed to those areas which will most benefit the future of the organisation. We need to work together to understand the importance of planning and the importance of getting some core processes in place, so that we can offer members more options and make our services attractive to new members.

Thinking positively - again - we have had to address our other areas of major expenditure and this has also made us sounder in terms of financial viability. At cost, however, as I deeply miss the printed version of the magazine and I am still hoping that there is someone out there who will come in and help us develop an on-line magazine in addition to the newsletter.

Thinking positively - again - don't overemphasise the threats, address them and overcome them but also work on the opportunities. Late last year I thought negatively when speaking to the Coffee and Chat Group when I said that I thought PCUG might not be here in ten years (I might have said five, I can't remember). In retrospect, like the member I referred to above, I think that I may have been too negative. We are currently defined as 'Users Helping Users'. The need to do that hasn't changed, merely the way we do it and recognition that those needs are changing. We may or may not have a TIP service in due course but the core requirement - helping users through the use of volunteers (and limited paid employment) - still exists. Opportunities exist in many areas - supporting internet games, training, looking after new retirees, providing shared facilities, and identifying real needs that aren't met by other community services or commercial providers.

I want to emphasise that we have a potential for a great future and that some of those expressing negative thinking (as opposed to constructive criticism) should, let's put it crudely, butt out. And here's a whinge. All too often (and we have another example in recent newsgroup comments) something happens and someone assumes the worst and then makes unjustifiable criticism without ascertaining facts or identifying the real problem needing resolving. Too often we find ourselves having to respond to an unjustified criticism supported by asserted facts where the accuser has been too lazy to do their homework but wants to add force to the criticism. We do respond to queries (mostly, but remember that we are volunteers too with limited time) and we would prefer to respond to genuine concerns rather than have to react to published criticisms which seem to be aimed more at damaging the organisation than resolving problems.

Another whinge (and I am sorry to bore those of you who don't read the newsgroups). Over many months much has been made of a perceived poor relationship between the TIP admins and the Committee. I have deliberately not responded to many comments, some of which come from TIP admins and some from other sources. First of all, we frequently communicate between each other in reasonable form on day to day matters and we do achieve things which benefit our members as a result. We find that we communicate face to face politely and without rudeness (but there has been some suspicion). I must add, however, that this does not always occur to the same degree in email transmissions. The problem is that email communication is often instant and reactive and without depth of thought as to how the respondent will receive the message in the form given. Some would say that computer experts are typically disadvantaged in their ability to communicate with other humans. Ho, ho, ho - no, that's not a Christmas call. It's laughter at my heartfelt support of those with that opinion. Secondly, the impression has been given that 'going public' in the newsgroup is out of frustration with not getting a response from the Committee - not so. However, I have not responded to the newsgroup items deliberately. (Those members who read the newsgroups have found this unusual, as I have usually responded rapidly to issues of concern raised by members). I do not wish, as a volunteer with limited time, to waste time in lengthy responses where genuine concerns and some very positive suggestions (a number of which have been looked at) have been mixed with innuendo, rudeness, false claims and abuse. Let us get the message across clearly. If you can't communicate clearly and politely then you usually don't get a response from me. I make the normal allowances for people who have problems communicating because of background and personal problems but I genuinely believe that people trained to high levels in computer skills are capable of communicating effectively and politely but they may need to make a little more effort than some.

One simple request - if you see something in the way PCUG operates that you don't like, talk to the Committee,



or if it is at the Centre, the Centre Manager. All members of the Committee are busy people - we cannot expect them to know everything that goes on unless they are told. A polite note or phone call about something you think needs to be fixed will always be welcomed.

Let me finish on a more positive note. We are deeply grateful to all our volunteers and that particularly includes the TIP admins, many of whom spend very large amounts of unrecognised time keeping the service running. Often this is done late at night and with significant loss of sleep. My gratitude also includes many unthanked others and I hope to give proper recognition to particular individuals as time goes on (if you have any suggestions as to who to thank email me as I am not always aware of how much a particular individual has contributed). This month I would like to thank in particular Allan Hepworth whose huge efforts in upgrading the Centre and supporting training facilities have made a very significant difference to the PCUG and have helped us to identify some of our future directions.

## PCUG Internet Service

Since the last newsletter we have made some more improvements to the PCUG Internet Service.

Transparent proxying on our internet service has now implemented. This means that you no longer MUST specify a proxy server in your browser configuration. The proxy server will continue to be used for all standard world wide web traffic. Existing configurations will continue to work and there is no need to change them.

If a proxy server is configured, that will be used. If none is specified, the TIP system will automatically forward all standard web traffic to our proxy server.

The TIP servers are now protected by a firewall. The servers are set up so that any connections initiated from them are OK, but inbound connections are only allowed to certain standard ports.

Currently the following ports inbound to all our machines (including members) are blocked:

TCP: 69 sunrpc ldap ldaps 135-139 445

UDP: tftp sunrpc snmp snmp-trap 2049 ldap ldaps 135-139 445

And outbound TCP: 135-139 445

The 135-139 range and 445 are to prevent the spread of the recent MS viruses that seem to be still with us.

Please send any requests for ports to be "opened" and report any problems to <help@tip.net.au>.

Effective in December the quota for hours connected to TIP for dial-in Full Service Users was increased with no increase in charges. The current limit for hours on line and the corresponding charges for dial-in Users are -

3 Months	90 Hours	\$ 41.80
6 Months	180 Hours	\$ 78.10
12 Months	360 Hours	\$145.20

Download limits are now the same for both dial-in and broadband Full Service Users - 6,000 Mb per year.

Broadband (always on) service is available to all members who have access to the TransACT cable or to TransACT ADSL services. The charges are (in addition to TransACT charges) -

2 Months	or 1,000MBytes	\$ 50.00
3 Months	or 1,500MBytes	\$ 75.00
4 Months	or 2,000MBytes	\$100.00
6 Months	or 3,000MBytes	\$150.00
12 Months	or 6,000MBytes	\$300.00

Effective the beginning of February we have added six more modems for use by dial-up users, giving our dial-up users access to a total of ninety modems.

### From the PCUG Centre Manager Allan Hepworth regarding the Training Facility

Just a quick reminder to members that if we want to keep our excellent training facility we need to externally hire the room two days a month. Keep your ears to the ground and spread the word about the facility.

## **Review of the Internet Services Sub-Committee**

In April 2003 the Committee decided to establish a new Sub-Committee which would report directly to the PCUG Committee, to be called the " Internet Services Sub-Committee" (ISSC). The ISSC replaced the Internet Project Management Committee which for various reasons was no longer working effectively.

The Terms of Reference of the ISSC given to the ISSC at its establishment are -  
Subject to the overall direction of the PCUG Committee -

the ISSC shall make all decisions relating to the financial, policy and administrative management of TIP;  
the ISSC shall oversight the implementation of policies approved by the Committee, including resolution of disputes between users and PCUG, application of PCUG rules and regulations;  
the ISSC shall monitor the operations of TIP, plan for future needs and developments, maintenance and replacement of equipment and the provision of finances as necessary to ensure the long term viability of TIP;  
the ISSC shall report all significant decisions and any decision involving expenditure exceeding \$1,000 to the PCUG Committee, but all decisions involving expenditure over \$2,000 shall be subject to approval in advance by the PCUG Committee.

The PCUG Committee appointed two officers of PCUG as the initial members of the ISSC, the PCUG LAN Manager (Allan Hepworth) and the Treasurer (Noel Matthews, who by agreement acts as Chairman of ISSC). Officer positions were nominated so that there would be a minimum of two people in the ISSC, irrespective of the personnel in the PCUG Committee. The two core members were under instructions to increase the membership of the ISSC by inviting, say, two members of the PCUG to join it as soon as possible.

At the time of its establishment the Committee agreed that the operation and effectiveness of the ISSC should be reviewed later in the year. On 16 November 2003 the Committee wrote to all members inviting them to submit comments and suggestions in relation to the operations of the ISSC or the operation of the PCUG Internet Service. Twenty two members responded to the invitation. All responses were scheduled and provided to all members of the Committee

### **Current Position**

The Committee members have been considering appropriate responses to the comments received. The Committee will decide on the action it will take at its next meeting, to be held on 9 February 2004. However it has already responded to some of the comments by appointing Harry Souter, a long-time member of PCUG who is not a member of the Committee, as the third member of ISSC.

Members will be advised of the Committee's decisions in the March newsletter.

## **Problems Logging into the Internet Service?**

**If you ever find yourself failing to log in to TIP, STOP and don't waste any more money trying to dial in again. The two major reasons for failing to login are firstly, you have run out of TIP or PCUG membership, or secondly, your Username and or your Password have become corrupt. Paying more money fixes the first problem, re-typing your Username and Password into the Log In dialogue fixes the second problem 99% of the time. If neither of those fixes works for you then telephone the PCUG Centre and ask for help (unless you can access someone elses email, in which case send an email to <help@tip.net.au>.**

### Firewalls - by Terry Bibo <bib063@tpg.com.au>

I was asked to discuss the setting up of XP's Internet Connection Firewall and the free ZoneAlarm, for a reading audience that didn't want to be burdened by complexities and hopefully would be able to just copy recommended settings. A big ask.

All installed programs have default settings, but these may not necessarily have any relationship to a particular user's wants. Take Microsoft Word. How many users accept the default template, normal.dot, without some modification of font, margins, layout, page size, etc.? Firewalls may have more-generic settings, and be able to determine others by interpretation of an individual user's settings for specific programs, such as browsers, mail clients, etc. But every firewall has to mould itself to the particular demands of every user's computer environment, and that inevitably requires user input - hence user decisions. And this is where the problem lies. Probably most of us do not have the expertise to answer all firewall queries confidently, but we all must be prepared to put some effort into resolving issues raised and learn from our experiences.

Firewalls are devices to enforce security between networks by guarding the ports through which network traffic - in our case only Internet traffic - comes in and goes out, and only let traffic through the ports that you have specified can be used. They prevent unauthorised access to your computer by hackers through an unguarded port, and prevent programs on your computer using unguarded ports to contact the outside world without your permission. Firewalls can be physical components attached to computers, or software programs installed on those computers. We will only consider these software programs that are broadly either application-based or rule-based.

Put very simply, an application-based firewall will permit or deny applications to connect to a network. Your web browser must be permitted to make an outgoing connection or you will never access the Internet. But, because Web servers do not open a connection to the client, we can deny incoming connections or require our firewall to ask for permission for every incoming request. ZoneAlarm is an application-based firewall.

In a rule-based firewall, anytime unknown network traffic is detected, the user will be asked whether the particular traffic can be permitted or denied, either for this single instance or for any further connections. If traffic is permitted or denied permanently, a corresponding rule is created automatically and users will not be asked about the particular traffic anymore. In both application-based and rule-based firewalls permissions can readily be subsequently changed. Kerio Personal Firewall is a highly regarded, free, rule-based firewall. Others are: Sygate Personal Firewall, Tiny Personal Firewall, and Outpost Firewall.

Windows XP's firewall describes itself as being a ' "stateful" (rule-based - Ed.) firewall that monitors all aspects of the communications that cross its path and inspects the source and destination address of each message that it handles. To prevent unsolicited traffic from the public side of the connection from entering the private side, (it) keeps a table of all communications that have originated from the computer. All inbound traffic from the Internet is compared against the entries in the table. Inbound Internet traffic is only allowed to reach the computers in your network when there is a matching entry in the table that shows that the communication exchange began from within your computer or private network.' I recommend you read the help file, starting with Internet Connection Firewall overview in Windows Help and Support. For the casual user without Internet Connection Sharing or a Home or Office Network, XP's firewall is a set-and-forget procedure. There will be major modifications to the firewall in XP Service Pack 2 due out in early 2004 that will probably not require your intervention.

For an overview of the performance of various firewalls as measured against Steve Gibson's Leaktest, go to <http://grc.com/lt/scoreboard.htm>. This report is based on user feedback. Note that Outpost Firewall is not listed, but I have been using it for at least two years and have checked it satisfactorily against Leaktest. If you need an

analogy to begin to understand firewalls go to [http://www.wilders.org/firewalls\\_m.htm](http://www.wilders.org/firewalls_m.htm), where a comprehensive table uses a major hotel telephone system to explain the concepts and protocols.

I have neither the capacity nor the interest to reinvent the wheel, and I realised soon after commencing this article that all the material for understanding setup problems is readily available. ZoneAlarm has an short Tutorial that provides an easy introduction to firewalls for even a novice. Its Help File expands on this up to a stage of considerable understanding, especially if all of its internal links are followed to gain an overall understanding. Let's have a quick look at ZoneAlarm anyway. Two issues are raised in the tutorial that warrant consideration. Knowing when to allow a program to make an outgoing connection to the Internet when a Program alert is raised is not always easy. Program alerts occur when a program on your computer tries to initiate a connection with a computer on the Internet and you have not already given it permission. The example given, Microsoft Outlook, is obvious because it needs access to the Internet to collect email. But what happens when the program wanting outgoing connection is Internet Explorer or Microsoft Word? And I have been presented with both of these and more-esoteric programs than these. Has Explorer or Word been hijacked by a Trojan and is it being used to create mischief? If in doubt say NO. But do not tick the Remember this answer the next time . . . box yet, in case the request is genuine and needed later on. The Internet itself is very useful here when the More Info box is ticked. Very often the resulting explanation is sufficiently encouraging to permit an easy decision. The Firewall alert referred to is easier to deal with. A Firewall alert means that ZoneAlarm has protected you by blocking traffic not allowed by your Firewall settings. Certainly the overwhelming majority of these attempts at incoming connection are harmful, and most firewalls prefer not to show them to you but keep a log that can be inspected later.

On installation ZoneAlarm provides default settings, and it will serve you well to inspect these soon after ZoneAlarm has learned about a few of your programs. Double-click the ZA icon in the system tray, click the Preferences tab, and then select Program Control. You will see something resembling this image:

You will get some idea of priorities by comparing those programs allowed only to access the Internet and use its resources, with those allowed also to act as a server making your computer's resources accessible to other computers on the Internet. Access permission allows a program on your computer to initiate communications with another computer. Server permission allows a program to monitor for connection requests from other computers and thereby initiate communications with yours. No program here is allowed to act as a server until given permission by the user. Several common types of applications, such as chat programs, and e-mail clients may need server permission to operate properly. But chat programs are notorious for using their file transfer to distribute worms, viruses, and Trojan horses. You can use this initial table as a guide for establishing permissions when subsequent Program alerts require your decision. Reading the Help file is an invaluable aid to understanding the problem.

Rule-based firewalls are far more configurable and therefore more demanding than application-based firewalls. They require a greater dedication to learning more about your computer system and dealing with firewall rules, ports, and protocols. Outpost uses plug-ins to also enable control of Cookies, Advertisements, ActiveX, JavaScript, VB Script, Pop-up windows, Browser content filtering, Email control, and Attachment filtering. Addressing rule-based firewalls is a subject unto itself. And, since I feel sure that the majority of readers will settle for the lesser burden of a competent ZoneAlarm, I will go no further. Interested readers should go to the home site of one or more of the rule-based firewalls listed or referred to in this article and its links.

NOTE: Firewalls are not necessarily compatible creatures, and running two firewalls simultaneously can have unpleasant results. In testing a few of these I disabled the running program and removed the Start-up items, but found that this does not remove active elements within the registry. It took a lot of effort with jv16 PowerTools to clean my registry after I had reduced XP to starting only in Safe Mode. For safety sake, ALWAYS uninstall a firewall before installing a different brand.

#### **Review - "Laurie's Picture Book Guide for Computers"**

The author, Laurie Fuller, says in his experience many computer books and most Help files leave a lot to be desired. He found that he had to do a lot of reading before he could do anything. This book is designed to eliminate the reading and to simply guide the user as he/she begins to do useful things, and at the same time teach by doing.

The book consists mainly of pictures of what you should see on the screen as you carry out a task, with enough notes and pointers to guide the new user along the right path. The book is not intended to be read from start to finish but to be picked up when a user begins a new task and to be put aside once the task is understood, until another new task is needed.

The pictures are clear and the notes very much to the point, so a new user is guided from beginning a task until its completion. After doing a task a couple of times with the help of this book, not only will the user be comfortable in doing it again, but also be on the way to understanding how computers work, and comfortable in trying other new tasks.

The book covers basics such as starting Windows, starting Word, making a letter head, writing a letter, then moves on to inserting clip art, inserting tables, preparing a spreadsheet, making greeting cards or fliers.

Altogether an excellent guide for beginners and well worth the price. In fact I was so impressed I bought two additional copies for my grandchildren.
