WELCOME TO THIS SPECIAL EDITION NEWSLETTER

The purpose of this newsletter is to reach all of our members with the news of the signing of our contract with TransACT to provide broadband internet access. On Sunday, 24th November we will have a combined **Thank you Party** for volunteers and a formal announcement of this new service.

Everyone is invited to attend and TransACT representatives will be there to answer questions. We will take initial expressions of interest in subscribing to broadband.

I would like to emphasise that the event on Sunday 24th November was originally planned as a special thank you to volunteers. I hope that volunteers will forgive us for combining the TransACT announcement with what is, in fact, a special thank you to them. The day seemed an ideal opportunity to invite not only the volunteers, but to extend the event to include members who wished to thank the volunteers, and to include those who wished to attend to ask about our agreement with TransACT.

To answer a few questions - we intend commencing in December, the earlier the better. The actual date will depend upon finalising software and testing. Those members currently using dial up who wish to transfer to broadband will be given credit for the unused portion of their dial up subscription. Credit given will reflect our normal policy on hours and time subscribed. Broadband subscribers will be able to use dial up but find that this is charged against their broadband account. This allows broadband subscribers to dial up from outside the TransACT coverage area, or away from their fixed connection, if they so wish.

Details of the charges and general conditions follow. Members will, when subscribing, be asked to sign a new agreement in place of the current *Acceptable Use Policy*.

We have also decided to give dial up users an off peak service, combined with a maximum megabyte download limit of 400 megabytes per month (averaged over the period paid for so you can download your full megabyte limit in a much shorter period). For example, a 12 month subscription gives you 4,800 megabytes and you could download all of this in as short a time period as is possible. You will find, however, that your connect time will limit how much you can download. Downloads during the off peak period will be counted at half the normal rate. It is important for dial up users to realise that to be recognised for the off peak service you must log on after 1.00 am and log off before 7.00 am. The date of implementation is to be advised.

1. Dial-Up Charges

The Committee has approved the following variations to dial-up access to be implemented at a date to be advised.

- a. A download limit at the rate of 400 megabytes per month is to be applied, pro-rated for the period paid for, e.g. 4,800 megabytes for a 12 month period. A review of download history has identified that this limit will have no effect on the majority of users. There will be no effect on the maximum download previously achieved by any existing user, i.e. heavy users, should they take advantage of the off-peak period and rates approved below.
- b. Data downloaded during dial-up sessions entirely within a defined off-peak period will be counted at half the normal rate i.e. users would need to log on after the start of the off-peak period (defined below as 0100 hours) and log off before the end (0700 hours). We reserve the right to adjust the off-peak times and rate at reasonably short notice.
- c. The off-peak period is initially defined as being from 0100 to 0700 hours (i.e. 1 a.m. to 7 a.m.).

2. Broadband Access

The PCUG has approved charges and conditions for broadband internet access as set out below.

Access is limited to residential users except that existing TIP members who are running a business may apply for connection as a special case. Each case will be considered on its individual merits and needs approval from both PCUG and TransACT. Use for business purposes would need to be similar to the type of use by a residential user. These charges are subject to amendment as and when necessary. Members signing up for this service will be required to agree to a revised "Internet Project Acceptable Use Policy" which is currently being prepared.

- a. Access to the internet through the PCUG TIP service using the TransACT network will allow unlimited on line time during the agreed period.
- b. The charging rate is \$25 (including GST) for one month of access or a limit of 400 megabytes download, whichever comes first.
- c. The minimum sign up period at any one time is two months or 800 megabytes download, whichever comes first.
- d. The download limit applies across the whole period paid for, e.g. if someone pays \$75, they are provided with 3 months or 1,200 megabytes, with the download being able to be used at any time within the period.
- e. All payments are to be made in advance of supplying service.
- f. Data downloaded during a defined off-peak period will be counted at half the normal rate. We reserve the right to adjust the off-peak times and rate at reasonably short notice.
- g. The off-peak period is initially defined as being from 0100 to 0700 hours (i.e. 1 a.m. to 7 a.m.).
- h. Broadband customers will have access to dial-up services but the megabytes downloaded will be treated as being part of the broadband access allocation (i.e. part of the 400 megabytes per month limit) and access will be limited to 25 hours per month (or pro-rata, e.g. an annual sign-up period will limit access to 300 modem hours for dial-up access and a total download limit of 4,800 megabytes whether the download is accessed under broadband or dial-up service).
- i. For users whose accounts end, special access will be allowed to permit on line renewal by credit card. This access will be to local TIP services and anything that is required for account renewal but for no other external access. This access will be restricted to seven days maximum or until the end of the current month, whichever is the sooner.

Vice-President:

I have been a member of the PCUG since 1997 and a member of the committee for several years. In the last election I was elected unopposed to the position of Vice President. I am currently a "house father" and believe that that gives me a little more time than some members (because my wife is working part time and takes over from me). Of course, paid employment would be welcome.

I believe that I have a lot to offer PCUG because of my previous experience in running a voluntary organisation. I was, for over 4 years, the Director of Business Services in the Victorian Division of the Australian Red Cross. In this position I was responsible for fundraising around \$7 million, for approximately 75 staff, jointly responsible for thousands of members and many thousands of volunteers who were not members (like the Red Cross Calling volunteers), responsible for merchandising (over 30 second-hand shops), and for financial management of the organisation. It was a very vibrant and well-managed organisation of which I was only one of the contributors.

I have also been employed at five Australian universities in administrative roles, including, in one university, administering the budgets for Arts and Science faculties to the tune of \$7-8 million each. I hold a Master of Business Administration degree from the University of Melbourne with honours in marketing and strategic planning subjects.

My wish is to re-vitalise the PCUG, to increase its membership and to ensure that members feel satisfied, and enjoy, what the PCUG provides for them.

I am the silent partner of a long time member of the PCUG and thought it was time to get involved. I hope to bring to this position my organisational and public relations skills. Over the coming weeks and months, I look forward to meeting the members and learning more about PCUG.

For the past 14 years I have worked at Canadian High Commission in Canberra, including 8 years as Head of the Academic and Public Affairs Section. My duties included the management of research grants, the supervision of staff and interns, liaison with media and government officials. Following a year-long working holiday in France, I am back at the High Commission in a more junior role, which provides me with some free time to devote to PCUG activities.

My past experience with committees has been as Coordinator of the annual Terry Fox Fun Run, the NSW branch of Oxfam/Community Aid Abroad and more recently 2 years with the ACT Veterans Athletic Club including one year as Treasurer.

John Bienkiewicz: I am a relatively newcomer to the PCUG – having been a member for just over one year. Many members reading this might think that a member of the committee should have more experience and knowledge of the group and I should begin by saying that to a certain extent I agree with them. I had originally intended to nominate for the committee in a few years time but it became fairly obvious to me that there was going to be a real shortage of committee members in the immediate future and such a shortage could be quite harmful to the group. Hence my nomination and subsequent "election" to the committee.

Rod Blackburn: I have been a member of PCUG for some three years and joined after visiting a Coffee and Chat meeting. I have learned a great deal through participation in that SIG and hope that I have been able to contribute to the resolution of other members' difficulties. As a result of this interaction I have volunteered to teach at the Belconnen library and have helped a number of people I have met there by visiting their homes.

I am retired, but spent the majority of my working career in the computer industry, mostly as a systems engineer with IBM giving support across a wide variety of industries.

I was particularly involved with retail systems and mainframe CAD systems, the latter finally leading me to working with AIX, IBM's UNIX operating system. I qualified as a mechanical engineer and worked initially in the motor industry and made a very small contribution to the design and development of some Vauxhall and Holden models in the '60s.

Perhaps because I now have time to be more adventurous in the things I do with it. Which things include editing a newsletter, photographic manipulation, home finances, personal communication and flight simulation.

Ann Byrne: (AKA Boop) : Member of the group since 1991 and on the committee in some form or another for 9 of those years. Love the group and know exactly how much it has to offer both in the practical sense but also the chance it gives you to make great friends.

I am now back on the committee: (a) because I was asked and (b) because I found the last AGM very sad to sit through, people as always telling us how to run the group but not so willing to help implement their ideas. I don't know if I can make a difference, but I certainly want to try, and to that end I am willing to once again spend the next 11 months giving it my best shot.

Graeme Evans has been a member of PCUG since 1997 and a member of the PCUG committee since 2001. He has for many years been an active participant in a wide range of community activities. Within the ACT these have focussed on land-use and social planning. He is currently president of Belconnen Community Council and is a former president of ACTCoSS, the Conservation Council and the ACT Council of Cultural and Community Organisations.

Graeme has a deep interest in the role of information technology as a central aspect of the way society as a whole is changing and growing. By contrast with many members of PCUG, he is much less interested (read - not interested) in the technical aspects of IT. Instead, he sees diversity within the committee (and the Group) as a useful way of widening the range of perspectives represented and brought to focus on issues which arise.

Outside PCUG, but still within the IT area, Graeme is a member (and deputy chair) of the ACT government's Community IT Advisory Group appointed earlier this year to advise on measures for the bridging of the digital divide.

Paul Free: I am retired, aged 79. I was an electrical engineer in the Public Service. I have spent half my life in the design and production of Equipment. I was previously the Commonwealth member of the Metric Conversion Board and was Divisional Head of the Department of Science.

During retirement I have been heavily involved in matters relating to older people. I was a board member of the Council of the Ageing and was Immediate Past President of the Superannuated Commonwealth Officers Association (ACT Branch).

I have belonged to the PC Users Group for approximately 10 years and I am a member of the daytime Internet Special Interest Group. I am keen to see PCUG continue and flourish.

Eleanor Rayment: I first joined in 1995 when the group was operating from Fyshwick. The reason I joined was because I bought a PC that year and a friend told me that I should join PCUG, because they will provide help if I needed it. I moved to Brisbane in 1996 for two years and when I returned, I decided to rejoin and because the group now operates from Belconnen, it is easier for me to become an active member. I am connected to the internet, because a friend gave me their access connection, but I would suggest that I would serve once every three or four months. 
