PCUG is not itself the supplier of ADSL CPE (Customers Premises Equipment), (modem, splitters and other devices) but offers CPE as an optional extra to the Residential DSL Service. Upon confirmation of the service delivery date, CPE is despatched overnight to the nominated end user address Australia wide and will be accompanied by fully detailed installation instructions for self-installation by the member.

PCUG will supply one of the following CPE if ordered with the application at the price shown -

In order that existing PSTN devices (such as telephones and fax machines) may continue to operate when the telephone line is used for ADSL an in-line microfilter must be installed between existing devices and the telephone line. The EM1100R microfilter enables these devices to continue to function normally over a combined ADSL & telephone line.

One microfilter comes with each Netcomm ADSL modem. If more are needed they must be ordered with the application.

Alternatively the ADSL POTS Splitter may be mounted on the incoming line, and all other telephone devices connected after it. The EM1180 POTS Splitter will allow the use of one telephone line for both Voice and ADSL services. The EM11800 minimises Voice Band Interference and eliminates the need for additional micro filters on each analog phone device, such as phone extensions, fax machines and telephone answering machines.

If a security Alarm with telephone line monitoring uses the same telephone line then a NetComm's EM1790 ADSL Alarm Panel Splitter must also be installed to allow the one telephone line to be used for both the security alarm and ADSL services.

CPE may also be ordered through PCUG at any time, but prices may vary – check with the PCUG Centre.

As prices can vary over short times, the price to members of the CPE supplied by PCUG should be confirmed from the Centre at the time of applying for the service.

Members may, if they choose to do so, purchase their own CPE for the ADSL service from a supplier of their choice. However the modem used must be approved by Telstra for use with the ADSL service. The CPE which are approved by Telstra for use with ADSL services are set out at <a href="http://www.telstra.com.au/adsl/equipmnt.htm">http://www.telstra.com.au/adsl/equipmnt.htm</a>.
